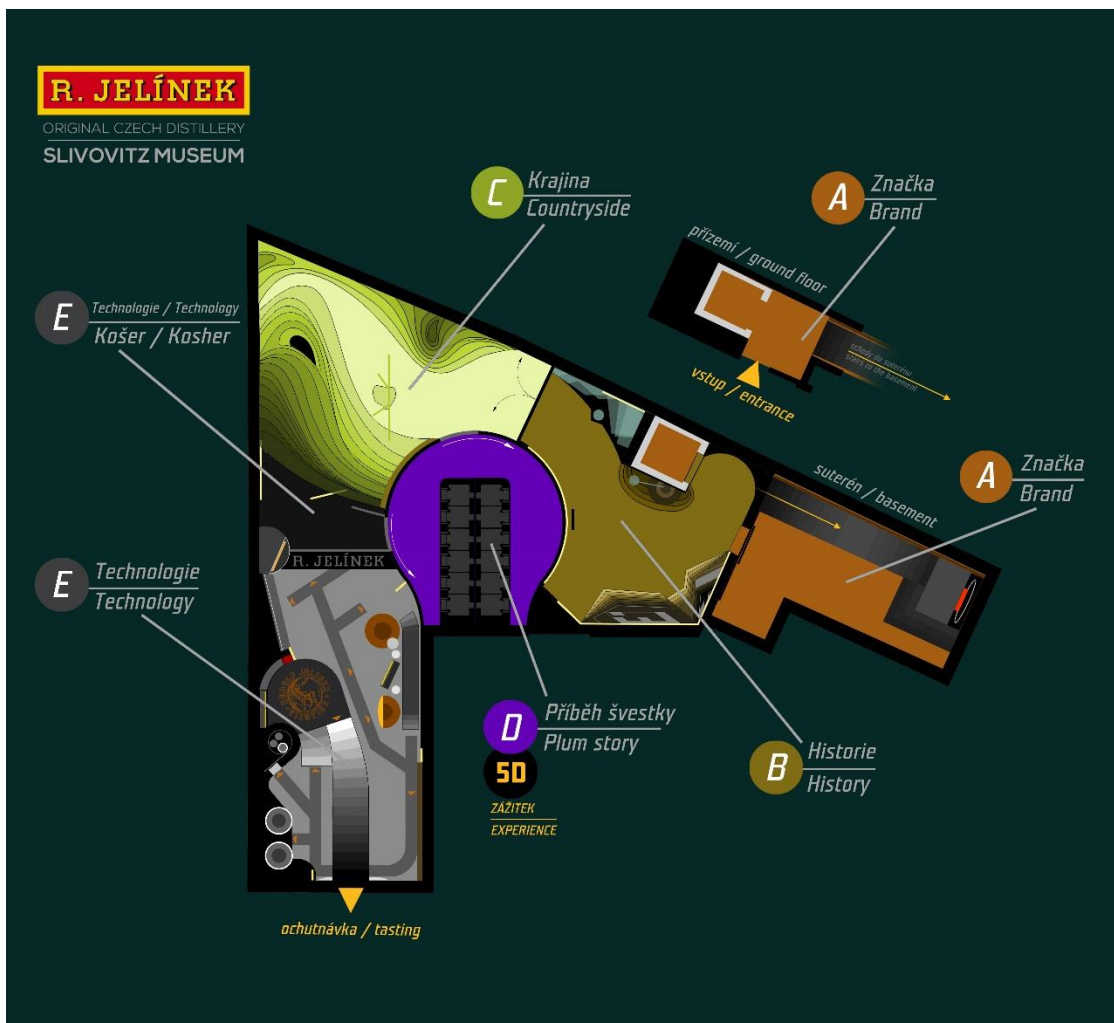


Visitor Rules of the Exhibition of the Museum Slivovitz R. JELÍNEK

ARTICLE 1 - GENERAL PROVISIONS

- 1.1. The Visitor Rules are issued by RUDOLF JELÍNEK a.s.
- 1.2. The operator of the exhibition of the Museum Slivovitz (hereinafter only MS) is RUDOLF JELÍNEK a.s., Razov 472, 763 12 Vizovice, Co. Reg. No.: 49971361, entered in the Commercial Register maintained by the Regional Court in Brno, file number 1253.
- 1.3. The exhibition is located at the address U Lužického semináře 116, 118 00 Prague 1.
- 1.4. The exhibition is open to visitors all year round, daily, according to the current opening hours, with the exception of days for which the operator reserved the right to hire the exhibition to groups on the basis of a confirmed order.
- 1.5. The visitor is obliged to pay the entrance fee to the exhibition in the specified amount. Children can visit the exhibition accompanied by a legal representative, or as part of a school group. A severely disabled person, who can prove it with a card, is entitled to a reduced entrance fee.
- 1.6. An audio guide system is available at the exhibition upon request.
- 1.7. Evacuation of the exhibition is determined by the "Building Fire Safety Regulations".

ARTICLE 2 - OBLIGATIONS OF THE VISITOR

- 2.1 A visitor means any person who comes to the MS in order to view the exhibition. Minors and legally incompetent persons must be accompanied by an adult who is responsible for them. Group visits consist of groups of a maximum of 12 people, groups of children must be accompanied by a teacher.
- 2.2 Every person entering the building is obliged to follow the instructions of authorized staff and to behave so as not to damage the building or its equipment.
- 2.3 The operator reserves the right to refuse admission or reject any person whose behavior is in conflict with the Visitor Rules of the Exhibition or who whose behavior is found to be indecent, without the option of reimbursement of the admission fee.
- 2.4 Persons under the influence of alcohol or other addictive substances, persons in heavily soiled clothing and persons who enter it for the purpose of door-to-door sales and intend to offer services or products without the permission of the building owner are not allowed to enter the MS exhibition.
- 2.5 It is forbidden to enter the MS with dogs.
- 2.6 It is forbidden to bring large pieces of luggage, sharp or any dangerous items into the MS exhibition, which may endanger safety of other persons. The MS employee has the right to decide whether such items are dangerous.
- 2.7 The doors that separate the individual parts of the exhibition are automatic and it is not allowed to interfere with them.
- 2.8 If a visitor causes any material damage, he is obliged to pay the costs of restoration.
- 2.9 Throughout the entire premises of the museum there is a ban on photography, video recording, touching exhibited objects, except for interactive exhibits, a ban on alcohol consumption and smoking, a ban on entry with animals, a ban on entry with fire and a ban on entry with weapons.
- 2.10 The visitor acknowledges that the entire MS building is monitored by industrial cameras.
- 2.11 In the event that any of the exhibits are out of order, it is properly marked with the "NOT FUNCTIONAL" sign and visitors are prohibited from handling such an exhibit in any way.
- 2.12 Visitors to the exhibition are obliged to behave respectfully towards other visitors (i.e. not to disturb them with inadequately noisy or otherwise eccentric behavior).
- 2.13 A visitor to the museum is obliged to behave in such a way that he or any other person are not in any danger from his actions.

ARTICLE 3 - SPECIAL PROVISIONS

Part of the tour of the MS exhibition is a virtual reality attraction (hereinafter referred to as VR) in the "Plum Story" area. By purchasing a ticket, the visitor agrees to the conditions of use of the attraction as follows.

- 3.1 The operator points out that the VR attraction is not suitable for every visitor, especially for people who suffer from dizziness, eye defects, loss of consciousness, headaches, high blood pressure, heart disease, spine pain, epilepsy, disorientation, disturbed balance or any other disease associated with the musculoskeletal system.
- 3.2 Persons under the influence of drugs or other addictive substances must not enter the VR attraction.
- 3.3 Some people may suffer from loss of balance, headaches, dizziness, etc. during and after their stay in virtual reality.

- 3.4 In exceptional cases, some people may suffer from epilepsy-like symptoms during and after their stay in the VR.
- 3.5 The VR attractions may not be suitable for people who are sensitive to odours or excessive noise.
- 3.6 The VR attraction is not suitable for pregnant and lactating women, people with visual impairments, people suffering from respiratory diseases and allergies.
- 3.7 The VR attraction is not intended for persons under 10 years of age. In case the attraction is visited by minors, consent of a legal representative is required.
- 3.8 The VR attraction is not recommended for the elderly.
- 3.9 Stay in the VR attraction should not be longer than 30 minutes.

ARTICLE 4 - WARNING OF INCREASED RISKS WHEN VIEWING THE EXHIBITION

A visitor enters the MS exhibition area voluntarily and is obliged to behave and move with caution. Not to enter areas and not sit anywhere other than the places designated for this purpose and not manipulate the exhibits contrary to their purpose.

- 4.1 Warning of the risk of a blow to the head in the area "Countryside" and "Technology"
- 4.2 Warning of the risk of falling when leaning over the railing in the "Technology" area
- 4.3 Warning of the risk of injury when handling the lockable boiler door in the "Technology" area

ARTICLE 5 - FINAL PROVISIONS

RUDOLF JELÍNEK a.s. does not bear any responsibility for injuries or damage caused by violation of the Visitor Rules. If a visitor causes damage by violating these Visitor Rules, he is obliged to provide a full compensation for such damage in accordance with the applicable laws and general legal regulations. If a visitor is unwilling to prove his/her identity, the assistance of the Czech police shall be requested. The scope, amount and method of compensation will be determined in accordance with the applicable regulations.

The Store and Exhibition Manager of the Slivovitz Museum is responsible for compliance with the Visitor Rules

These Visitor Rules come into force on 1. March 2020.
